Question

To persist and survive in any environment, a tree must be mechanically reliable and achieve a reasonable factor of safety. The susceptibility of tree stems to mechanical failure increases as a tree increases its height and mass weight. As early as the 1800's wind has been identified as a significant factor affecting the growth of trees. The adaptive growth response of trees to forces such as wind was named thigmomorphogenesis.

- a) Explain the forces and loading that occur on trees from the effects of wind using the following headings:
 - i) Growth form and lever effect
 - ii) Wood Strength
 - iii) Elastic Limit and Elasticity
 - i) Applied and Resistive Bending Moment

- b) Describe in biomechanical terms the combined effects that wind and crown lifting can have on the safety factor of trees.
